YOU ARE ELIGIBLE TO VOTE ON BALLOT MEASURE QS

Dear Voter,

We are writing regarding the Santa Monica-Malibu Unified School District's (SMMUSD) school bond measures that appear on your ballot. Both Measure QS, a school bond measure for Santa Monica schools, and Measure MM, a school bond measure for Malibu schools, were mistakenly included on ballots for all voters within the entire school district instead of being included only for eligible voters within each community.

While the voting materials cannot be changed, corrective actions have been taken to ensure only votes cast by eligible voters within the respective communities are reported and certified.

You are eligible to vote on Ballot Measure QS.

Only votes cast by voters registered in Santa Monica (School Facility Improvement District 1) will be reported and included in the final election results for Measure QS. This does not affect any other contest or measure on your ballot.

**Santa Monica-Malibu Unified School District – (1) General Obligation Bond
Vote Passage- 55% of the Votes Cast**

MEASURE QS - SANTA MONICA SCHOOLS REPAIR/IMPROVEMENT BOND MEASURE

To repair/replace leaky school roofs, outdated wiring/ plumbing; remove hazardous materials; upgrade classrooms, labs, instructional technology supporting science, math, engineering; improve education for struggling students; and increase student/ school safety; shall Santa Monica-Malibu Unified School District's measure for School Facilities Improvement District No.1 (Santa Monica Schools) be adopted authorizing \$495,000,000 of bonds at legal interest rates, levying 3¢ per \$100 assessed value (raising \$28 million annually) while bonds are outstanding, with citizens' oversight, annual audits, and all funds for Santa Monica schools only?
