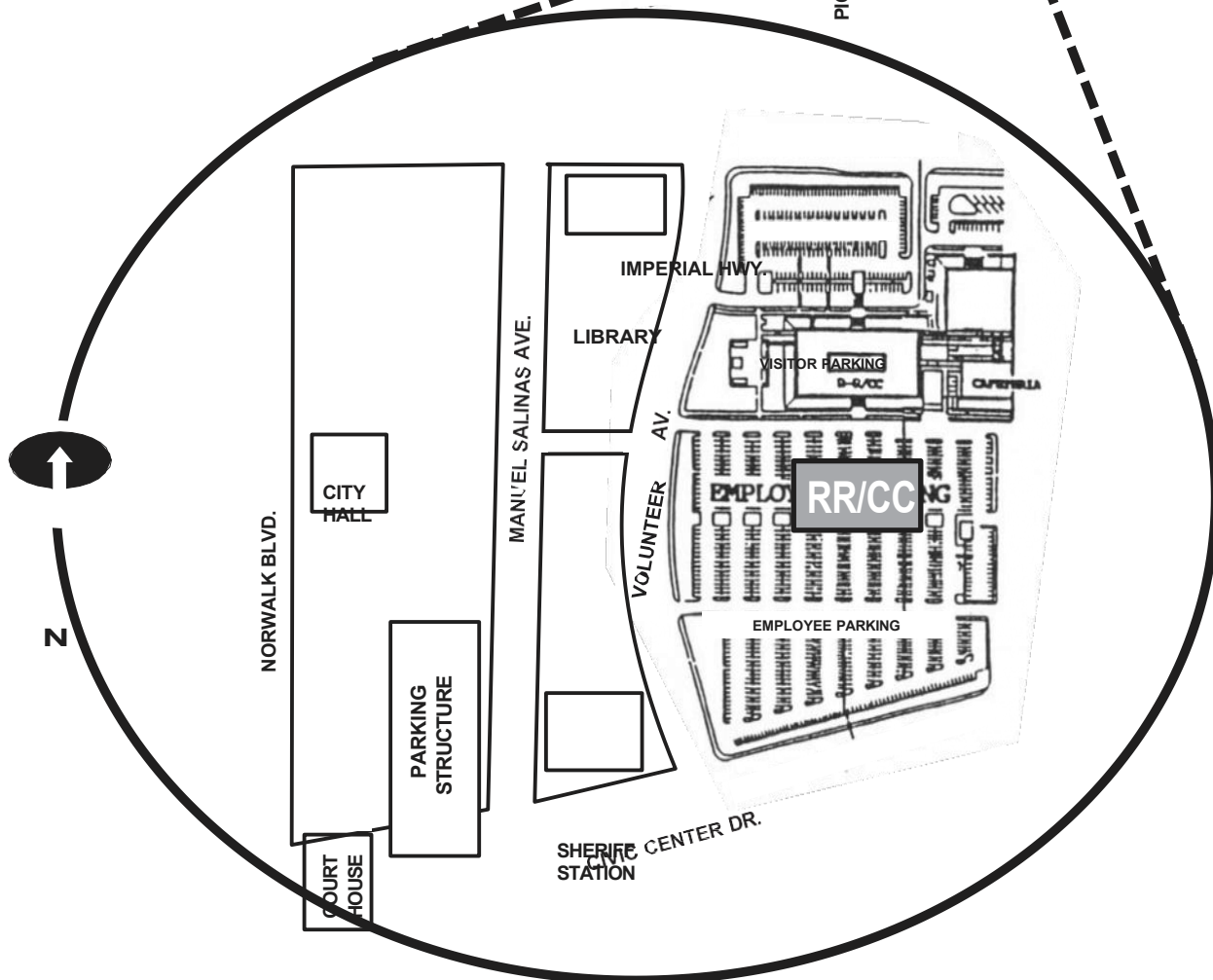
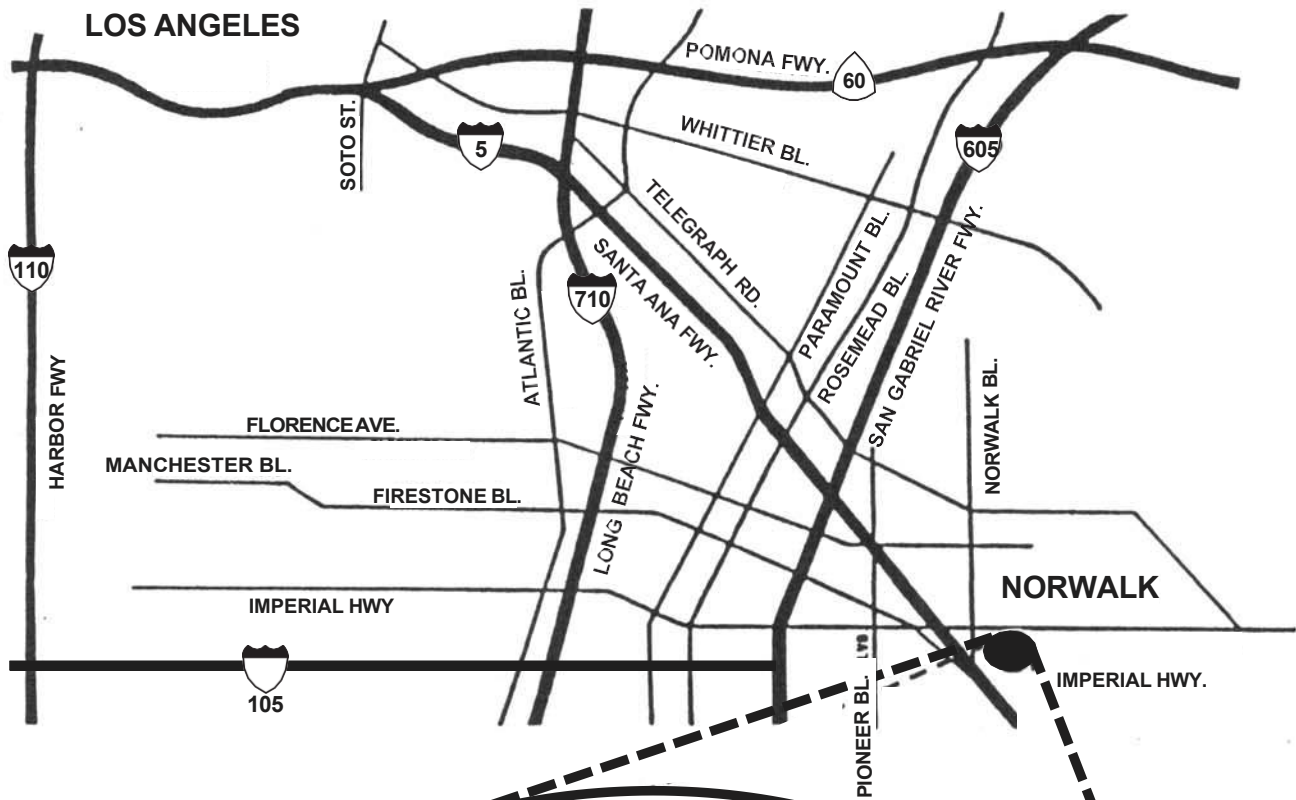

During this period, petition forms may be obtained to secure signatures in lieu of all or a portion of the filing fee. Signatures submitted on the in-lieu petitions may also be applied to the signature requirements for offices on the nominating petition. **Candidates will be notified of any deficiency within 10 calendar days of filing the petition.** Candidates other than for judicial office may then, prior to the close of the nomination period, pay the pro rata portion of the filing fee to make up the deficiency.

First and last day for candidates for judicial office to file a declaration of intention. The filing fee must be paid or signatures in lieu of filing fee petitions must be filed at the time the declaration of intention is filed.

**SIGNATURE IN LIEU OF FILING FEE PETITIONS DEADLINE – ALL OFFICES**

Last day to file signatures in lieu petitions. Candidates other than for judicial office will be notified of any deficiency within 10 calendar days of filing the petition. Candidates may then, prior to the close of the nomination period, pay the pro rata portion of the filing fee to make up the deficiency.

**EXTENSION OF DECLARATION OF INTENTION PERIOD (JUDICIAL OFFICE ONLY)**

If the incumbent for a judicial office does not file a declaration of intention to succeed to the same office by **February 4**, qualified persons other than the incumbent may file a declaration of intention for that office no later than the first day for filing nomination papers.  
(E. C. § 8023 (b))

**NOMINATION PERIOD FOR ALL CANDIDATES**

During this period, all candidates must file declarations of candidacy and nomination papers. No person may file nomination papers for more than one federal or state office at the same election. The Declaration of Candidacy shall be executed in the elections official's office. All candidates must pay the nonrefundable filing fees. A candidate shall not be required to execute a nomination paper if the number of in lieu signatures that meets the nomination requirement on the in lieu petitions equals or exceeds the minimum number required. (E. C. §§ 8020, 8061, 8062, 8100, 8105, 8106 and 10407)

**SIGNATURE IN LIEU PETITIONS CHECKED**

Last day to determine sufficiency of signatures in lieu of filing fees submitted by all candidates. If determined that the petition is deficient, the candidate shall then, at the time of obtaining nomination forms, pay a pro rata portion of the filing fee to cover the deficiency. (E. C. § 8106(b)(3))

If nomination documents for any eligible incumbent are not filed by **March 6, 5:00 p.m.**, the nomination period for such office shall be extended until **March 11, 5:00 p.m.** for **persons other than the incumbent.**

**NOTE:** Extension period does not apply when:

- 1) the incumbent for judicial office does not file a declaration of intention for the office
- 2) there is no incumbent eligible to be elected or the incumbent has served the maximum number of terms as permitted by the California Constitution or Los Angeles County Charter
- 3) the office in question is for county central committee, central committee or county council (E.C. §§ 8022, 8024, 8204 and 10407(b))

## SIGNATURES IN LIEU OF FILING FEE PETITIONS

(E. C. Sec. 8106)

### STATEWIDE DIRECT PRIMARY ELECTION

**SIGNATURES IN LIEU OF THE FILING FEE** – A candidate may submit a petition containing signatures of registered voters in lieu of paying the filing fee to run for office. Candidates for Superior Court Judge must submit signatures in lieu of filing fee petitions at the time the candidate files the Declaration of Intention. Candidates for all other offices must submit signatures in lieu of filing fee petitions by **February 4, 2026**. The signatures submitted may cover all, or a prorated portion, of the filing fee. Official filing documents are available between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, excluding holidays, at the:

**FILING FEE REQUIRED** – State law requires that a filing fee be paid by the candidate, exclude Superior Court Judge) at the time the nomination documents are issued. Filing fees may be paid in cash or by certified cashier's check or personal check. Checks are to be made **payable to the Secretary of State for all state and federal offices and to the Registrar-Recorder/County Clerk for all county offices. All filing fees** received by the Secretary of State and county elections officials **are non-refundable**. The start date for the Signatures in Lieu will be **December 19**. The final day to submit Signatures in Lieu will be **February 4, 2026**. Upon request, this office will provide each candidate or their authorized representative with the necessary forms to gather signatures, free of charge. If additional copies are needed, candidates may reproduce the provided forms.

**Candidates for Superior Court Judge must pay the filing fee at the time the Declaration of Intention is filed.**

Signatures in lieu of the filing fee are verified within ten (10) days after submission. Candidates will be notified of the number of valid signatures. If the requisite number of valid signatures has been met, no additional signatures are needed. If the requisite number has not been met, the candidate has the option of paying the pro rata amount of the filing fee to cover any invalid signatures **by 5:00 p.m. on the last day to file nomination documents**.

**Signatures in lieu of filing fee** petitions must be filed no later than the applicable filing deadline. Valid signatures on signatures in lieu petitions may be applied to the nominating petition signature requirement. However, signatures in lieu petition forms cannot be substituted for purposes of filing nominating petitions. Nominating petition forms will be available commencing **February 9, 2026, and must be filed by 5:00 p.m. on March 6, 2026**.

1. An active or inactive advanced certificate issued by the Commission on Peace Officer Standards and training.
2. One year of full-time, salaried law enforcement experience as specified, of which at least a portion shall have been accomplished within five years prior to the date of filing, and possesses a master's degree from an accredited college or university.
3. Two years of full-time, salaried law enforcement experience as specified, of which at least a portion shall have been accomplished within five years prior to the date of filing, and possesses a bachelor's degree from an accredited college or university.
4. Three years of full-time, salaried law enforcement experience as specified, of which at least a portion shall have been accomplished within five years prior to the date of filing, and possesses an associate in arts or associate in science degree or the equivalent from an accredited college.
5. Four years of full-time, salaried law enforcement experience as specified, of which at least a portion shall have been accomplished within five years prior to date of filing, and possesses a high school diploma or equivalent.

Voters established term limits for Sheriff, beginning December 2002. On October 29, 2004 the Superior Court voided term limits for the Sheriff.
