**SUBMIT TO THE VOTERS THE INITIATIVE ORDINANCE FOR THE CONSOLIDATED
FIRE DISTRICT OF LOS ANGELES COUNTY EMERGENCY RESPONSE AND
INFRASTRUCTURE SPECIAL PARCEL TAX (ALL SUPERVISORIAL DISTRICTS) (3
VOTES)**

This is to inform you that the review of the Consolidated Fire District of Los Angeles County Emergency Response and Infrastructure Special Parcel Tax Initiative Ordinance Petition, received on June 3, 2024, was completed by my office. The review of petition signatures was conducted in accordance with the California Elections Code and Code of Regulations. In accordance with Elections Code Section 9309, my office examined the signatures on the initiative petition using a random sampling technique (i.e., verifying a random 3 percent sample of the signatures in the Petition) and found the petition to be sufficient. Enclosed is the certificate reporting the results of the signature verification.

Pursuant to Elections Code Section 9310, your Board, also acting as the governing body of the Consolidated Fire Protection District of Los Angeles County, shall submit the ordinance, without alteration, to the voters in accordance with Elections Code Section 1405.

CERTIFICATE

OF INITIATIVE PETITION

I, **DEAN C. LOGAN**, Registrar-Recorder/County Clerk of the County of Los Angeles, of the State of California, DO HEREBY CERTIFY:

That the **CONSOLIDATED FIRE DISTRICT OF LOS ANGELES COUNTY EMERGENCY RESPONSE & INFRASTRUCTURE SPECIAL PARCEL TAX INITIATIVE ORDINANCE** petition was filed with this office on June 3, 2024.

That said petition consists of 31,404 sections; containing 182,497 signatures;

That each section contains signatures purporting to be the signatures of qualified electors of this county;

That attached to this petition at the time it was filed was an affidavit purporting to be the affidavit of the person who solicited the signatures, and containing the dates between which the purported qualified electors signed this petition;

That the affiant stated his or her own qualifications, that he or she had solicited the signatures upon that section, that all of the signatures were made in his or her presence, and that to the best of his or her knowledge and belief each signature to that section was the genuine signature of the person whose name it purports to be;

That after the proponent filed this petition, I verified the required number of signatures by examining the records of the registration in this county, current and in effect at the respective purported dates of such signing, to determine what number of qualified electors signed the petition, and from that examination I have determined the following facts regarding this petition:

1. Number of signatures filed by proponent: 182,497
2. Number of signatures verified (3%): 5,476
3. Number of signatures found VALID: 4,174
4. Number of signatures CHALLENGED: 1,302
5. Number CHALLENGED because DUPLICATE: 0
6. Required number of valid Signature: 112,546
7. Projected number of valid signatures (from 3% random Sample): 139,106 (123.60%)
