MEASURES APPEARING ON THE BALLOT

STATE MEASURES – (14)

- 1 AUTHORIZES BONDS FOR HOUSING AFFORDABILITY PROGRAMS. LEGISLATIVE STATUTE.** Authorizes \$11.25 billion in state general obligation bonds for housing affordability programs, including multifamily rental housing, mortgages for veterans, supportive housing, preservation of existing affordable housing, and downpayment assistance. **Fiscal Impact:** Increased state cost of \$500 million to \$600 million annually for about 25 years to repay the housing bond. **Supporters:** US Vets; CA Federation of Teachers; Self-Help for the Elderly; Habitat for Humanity CA; CA Alliance of Child & Family Services **Opponents:** None submitted.
- 2 INCREASES STATE'S RAINY DAY FUND. LEGISLATIVE CONSTITUTIONAL AMENDMENT.** Increases California's Rainy Day Fund, approved by voters in 2014, to provide funding for education, health care, public safety, and other essential services during economic downturns. **Fiscal Impact:** State budget reserves would be higher. **Supporters:** CA Professional Firefighters; LA Chamber of Commerce; Gavin Newsom; Xavier Becerra; Assemblymember Jesse Gabriel **Opponents:** None submitted.
- 3 PROVIDES PERMANENT FUNDING FOR SCHOOLS AND HEALTH CARE BY EXTENDING EXISTING TAX ON HIGH INCOMES. INITIATIVE CONSTITUTIONAL AMENDMENT.** Makes permanent existing voter-approved tax rates for individuals earning over \$371,000 (adjusted annually for inflation). Allocates tax revenues to public education. **Fiscal Impact:** Maintains \$5 billion to \$15 billion of annual state income tax revenue by making a temporary tax increase on high-income earners permanent instead of letting it expire in 2031. **Supporters:** California Teachers Association; CA School Nurses Organization; California State PTA; Planned Parenthood Affiliates of CA **Opponents:** California Taxpayers Association; Family Business Association of California; California Hispanic Chambers of Commerce
- 4 REPEALS PROHIBITION AGAINST PUBLIC FUNDING OF ELECTION CAMPAIGNS. LEGISLATIVE STATUTE.** Repeals prohibition on state and local governments offering public funding of candidate election campaigns. Public funding programs may not use funds earmarked for education, transportation, or public safety. **Fiscal Impact:** Ongoing costs to the state of a few hundred thousand dollars each year for the Fair Political Practices Commission to answer questions from state and local governments about public campaign finance programs. **Supporters:** League of Women Voters of CA; California Nurses Association; Mental Health Advocacy; Social Security Works; Consumer Watchdog **Opponents:** California Taxpayers Assn; Howard Jarvis Taxpayers Assn; Family Business Assn of California; United Latinos Action

STATE MEASURES – (14) Continued

- 5 CHANGES RECALL ELECTION PROCESS FOR STATEWIDE OFFICERS. LEGISLATIVE CONSTITUTIONAL AMENDMENT.** Under current law, voters elect replacement candidates at the same time as the recall election. This measure instead fills recall vacancies by subsequent special election or appointment. **Fiscal Impact:** Net fiscal effect unknown. In the event of a recall, savings or costs of millions of dollars to administer the election depending on the office recalled. **Supporters:** None submitted **Opponents:** None submitted.

- 37 CREATES LOAN PROGRAM FOR MIDDLE-INCOME BUYERS OF QUALIFIED NEW HOMES. INITIATIVE STATUTE.** Authorizes \$25 billion in bonds to offer eligible buyers fixed-rate mortgages for up to 17% of purchase price of a newly constructed home priced below about \$1.5 million. Borrowers must be California residents, occupy the home, meet income limits, and pay at least 3% down. Bonds repaid by mortgage payments, not State. **Fiscal Impact:** No direct state or local costs. **Supporters:** United Nurses Associations of California; California Conference of Carpenters; California State Treasurer Fiona Ma **Opponents:** None submitted.

- 38 AUTHORIZES BONDS FOR IMMUNOLOGY MEDICAL RESEARCH. INITIATIVE STATUTE.** Authorizes \$8.4 billion in general obligation bonds for immunology and immunotherapy research, half to a single University of California-affiliated nonprofit medical research institute, half to research grants. **Fiscal Impact:** Increased state cost of \$500 million to \$600 million annually for about 20 years to repay the research bond, with some or all of the cost offset if the funded research generates revenue. **Supporters:** Michael J. Fox Foundation; Alzheimer's Los Angeles; Kidney Cancer Assoc; American Nurses Assoc\CA **Opponents:** Robert M Kaplan Ph.D.

- 39 PROHIBITS CITIZENS FROM VOTING UNLESS THEY PRESENT GOVERNMENT-ISSUED IDENTIFICATION. INITIATIVE CONSTITUTIONAL AMENDMENT.** Invalidates mail ballots that do not have last four digits of designated government-issued identification number written on envelope. Prohibits in-person voting without presenting government-issued identification. **Fiscal Impact:** Costs of between tens of millions of dollars and low hundreds of millions of dollars each year to implement new voting requirements. **Supporters:** The Transparency Foundation; Latino American Political Assn; Howard Jarvis Taxpayers Assn; CA Women's Leadership Assn **Opponents:** ACLU California Action; Common Cause; League of Women Voters of California.

- 40 IMPOSES ONE-TIME TAX ON CERTAIN TAXPAYERS. INITIATIVE CONSTITUTIONAL AMENDMENT AND STATUTE.** Imposes 5% tax on certain taxpayers with assets over \$1 billion; revenue primarily for health care. Exempts revenues from constitutional requirements for school funding and spending limit. **Fiscal Impact:** Temporary revenue increase of tens of billions of dollars spread over several years from wealth tax on billionaires. Possible ongoing decrease of less than \$1 billion per year in income tax revenue from billionaires. **Supporters:** US Senator Bernie Sanders; SEIU United Healthcare Workers West **Opponents:** California Primary Care Association; California School Boards Association; California Taxpayers Association.

STATE MEASURES – (14) Continued

- 41 PROHIBITS NEW STATE TAXES THAT EXCLUDE REVENUES FROM STATE SPENDING LIMIT. REQUIRES AUDITS FOR NEW STATE SPECIAL TAXES. INITIATIVE CONSTITUTIONAL AMENDMENT.** Nullifies state taxes enacted after January 1, 2026 that exempt their revenues from voter-approved state spending limit. Requires pre-election and recurring audits of programs funded by new special taxes. **Fiscal Impact:** The net fiscal effect is unknown as it depends on future decisions by voters, the Legislature, and other policymakers. **Supporters:** CA Society of Certified Public Accountants (CalCPAs); CalAsian Chamber of Commerce; California Taxpayers Association (CalTax) **Opponents:** US Senator Bernie Sanders; SEIU United Healthcare Workers West
-
- 42 PROHIBITS NEW STATE PERSONAL PROPERTY TAXES AND CERTAIN RETROACTIVE STATE TAXES. INITIATIVE CONSTITUTIONAL AMENDMENT.** Prohibits any new state tax (1) imposed on the ownership of personal property (all things people own other than real estate), or (2) that applies retroactively based on taxpayer's past activities. Nullifies taxes enacted after January 1, 2026 that conflict with this measure. **Fiscal Impact:** Possibility that tax revenues will not go up as much in the future. **Supporters:** CA Professional Firefighters; State Building & Construction Trades Council of CA; AMVETS Department of CA **Opponents:** US Senator Bernie Sanders; SEIU United Healthcare Workers West
-
- 43 LIMITS VOTERS' ABILITY TO RAISE REVENUES FOR LOCAL GOVERNMENT SERVICES. LEGISLATIVE CONSTITUTIONAL AMENDMENT.** Limits voters' ability to pass voter-proposed local special taxes by increasing percentage of votes needed to approve such ballot measures from a majority (over 50%) to two-thirds, beginning January 1, 2027. **Fiscal Impact:** Possibility that local government tax revenues will not go up as much in the future due to a higher vote threshold for certain taxes. **Supporters:** California Taxpayers Association; Family Business Association of California; California Hispanic Chambers of Commerce **Opponents:** California Professional Firefighters; California Federation of Teachers; Nurse Alliance of SEIU CA
-
- 44 REQUIRES COMMUNITY HEALTH CLINICS SPEND 90% OF REVENUE ON PROGRAM SERVICES. INITIATIVE STATUTE.** Imposes penalties on nonprofit Federally Qualified Health Centers (community clinics providing primary care to medically underserved areas and populations) that spend less than 90% of revenue on "program services" advancing their charitable purpose, including but not limited to patient services. **Fiscal Impact:** Increased state costs in the low tens of millions of dollars per year, covered by fees. **Supporters:** None submitted **Opponents:** American Academy of Pediatrics CA; CA School Nurses Org; CA Academy of Family Physicians; CA Medical Assoc.

- 45 MODIFIES ENVIRONMENTAL REVIEW FOR CERTAIN PROJECTS. INITIATIVE STATUTE.** Amends California Environmental Quality Act (CEQA) to expedite environmental review for certain projects (including most housing, transportation, water, and health projects) by setting deadlines to complete environmental review and resolve lawsuits challenging project approvals. **Fiscal Impact:** Initial costs for state and local governments, likely in the high tens of millions of dollars-potentially exceeding \$100 million-annually, partly covered by fees. Uncertain, potentially more significant positive or negative longer-term fiscal effects. **Supporters:** California Children's Hospital Association; California Water Association; California Council for Affordable Housing **Opponents:** Coalition for Clean Air; CA Environmental Voters; Physicians for Social Responsibility, LA; National Wildlife Federation

- A** **LOS ANGELES COUNTY CHARTER AMENDMENT REITERATING GOOD FAITH NEGOTIATION OBLIGATIONS AND ESTABLISHING IMPARTIAL BINDING ARBITRATION FOR CERTIFIED PUBLIC SAFETY EMPLOYEE DISPUTES** Shall the measure amending the Los Angeles County Charter to prohibit strikes by district attorney investigators, medical examiners, and lifeguards; their supervisors; and nonadministrative civilian employees working in the Fire Department, Sheriff's Department, and the Department of Medical Examiner, reiterate existing legal obligations for good faith negotiations, and establish an impartial binding arbitration process for resolving labor disputes with certified public safety employee organizations representing County employees including firefighters, sheriffs, and the abovementioned employees, as specified in the charter amendment ordinance, be adopted? **Supporters:** LA County Firefighters Local #1014; Association of LA Deputy Sheriffs; LA/OC Building Trades Council **Opponents:** None submitted.

- E** **PROPOSED COUNTY CHARTER AMENDMENT. COUNTY OF LOS ANGELES ETHICS COMMISSION AND COMMUNITY INVESTMENT BUDGET ALLOCATION CHARTER AMENDMENT.** Shall the measure amending the Los Angeles County Charter to provide greater independence and structure for the County of Los Angeles Ethics Commission, Office of Ethics Compliance, and Ethics Compliance Officer, including appointment processes, qualifications, term, duties and responsibilities, and to continue uninterrupted the County's commitment to community investment and alternatives to incarceration, as specified in the charter amendment ordinance, be adopted? **Supporters:** League of Women Voters of LA County; CA Clean Money; Supervisor Lindsey Horvath; CA Common Cause; AAPI Equity Alliance **Opponents:** None submitted.

VOTE PASSAGE – Majority Vote 50%+1

- HT** Modernization/No Tax Rate Increase Measure. To maintain city services, such as: Fire protection, paramedic, 911 emergency response, crime prevention and keeping streets, infrastructure, and parks safe and well-maintained shall City of Alhambra's measure modernizing the hotel/motel transient occupancy tax be adopted at the current 12% rate for stays up to 30 days to include short-term lodging, providing an additional \$134,000 annually for city services until ended by voters, with all money locally controlled? **Supporters:** Alhambra Firefighters Association; Alhambra Police Officers Association **Opponents:** None submitted.

- DB** Data Centers Prohibited. CR **Good Government Cannabis Reform Measure** To fund general city services in Baldwin Park, such as cleaning trash/graffiti, fixing streets/potholes, crime prevention, 911 emergency response, and providing afterschool/youth employment programs, shall the measure applying the City of Baldwin Park's existing 4% cannabis retailing tax rate to non-retail cannabis businesses, providing a projected \$1,000,000 annually in additional locally controlled funding until ended by voters, that can't be taken by the state, with public independent audits be adopted? **Supporters:** Daniel Damian, Lakeside Realty & Home Loans; Javier E. SM With funds that cannot be taken by the State and spent elsewhere, shall Bellflower Unified School District's measure to repair/replace deteriorating roofs, plumbing, heating, ventilation and electrical systems; upgrade classrooms, labs and career training facilities; and, improve access for students with disabilities be adopted, authorizing \$135 million in bonds levying \$49 per \$100,000 assessed value (\$8 million annually) while outstanding, with legal rates, audits, citizen oversight, no funds for administrator salaries and full disclosure of all spending? **Supporters:** Asm.
