COUNTY MEASURES – (1)

LOS ANGELES COUNTY – (1) VOTE PASSAGE – Majority Vote 50%+1

- ER- Essential Services Restoration Act for Los Angeles County General Sales Tax Measure.** Shall the measure to help our community address severe federal cuts enacted by the President and Congress; reduce the loss of essential services, including healthcare for County residents; reduce the risk of closing the County's four public hospitals and numerous clinics, and significant healthcare provider layoffs and other service cuts by enacting a 1/2 percent (0.5%) general sales tax for 5 years, generating approximately \$1 billion annually, with independent audits, be adopted? **Supporters:** St. John's Community Health; Planned Parenthood Advocacy Project; LA County Medical Association **Opponents:** LA Taxpayers Assoc.; Sup. CITY OF BELL – (1) VOTE PASSAGE – Majority Vote 50%+1

- BB- City of Bell Public Safety/City Services Measure:** To help secure the City of Bell's financial stability and maintain municipal services, including fire, paramedic, 911, police services; prevent crime/thefts; keep public areas and parks safe/clean; maintain streets, youth/afterschool and anti-gang programs; address homelessness; shall the measure establishing a 1¢ sales tax, generating approximately \$3,500,000 annually until ended by voters; requiring independent audits/Citizens' Oversight committee, public spending disclosure, with all funds locally controlled, be adopted? **Supporters:** I. Bernal, Crime Watch; A. Tehfi, World Famous Grill; R. Ortiz, D'Todo Natural; N. Farhat, Cedars Halal; A. Naples, Ballerz Tires. **Opponents:** None submitted.

CITY OF BELL GARDENS – (1) VOTE PASSAGE – Majority Vote 50%+1

- BG- Keep Bell Gardens Sales Tax Revenues Local Measure.** To protect and stabilize funding for Bell Gardens services like police/emergency response; maintenance/repair of streets, sidewalks and City facilities; park maintenance and enhancements; youth/senior programs; Community Family Service Center; and for any other general governmental purpose, shall the City's current 3/4% transactions (sales) and use tax rate be increased by a quarter percent to 1% to raise an additional \$1.2 million annually? **Supporters:** Mayor Miguel De La Rosa; Mayor Pro Tem Isabel Guillen; Councilmembers Marco Barcena, Jorgel Chavez, Francis De Leon Sanchez **Opponents:** None submitted.

BONITA UNIFIED SCHOOL DISTRICT – (1)

VOTE PASSAGE – 55% of the Votes Cast

- A-** **Bonita Unified School District Classroom Repair, Safety, Upgrade Measure.** To upgrade fire safety, science/career training classrooms; replace 40-year old air conditioning/heating/ventilation systems; remove hazardous materials; repair leaky roofs; repair, construct, acquire classrooms/sites/facilities/equipment helping recruit/retain teachers, shall Bonita Unified School District's measure authorizing \$256,000,000 in bonds, at legal rates, levying \$59 per \$100,000 of assessed valuation raising \$16,000,000 annually while bonds are outstanding be adopted, requiring oversight/audits/spending disclosure, funds for local schools? **Supporters:** La Verne Mayor, Tim Hepburn; San Dimas Mayor, Emmett Badar; Bonita Unified Teachers Assoc.; Bonita Council PTA; Curtis Frick **Opponents:** None submitted.

CITY OF CARSON– (1)

VOTE PASSAGE – Majority Vote 50%+1

- FW-** Shall the measure, placed on the ballot by initiative petition, allowing the sale, from up to 12 permitted temporary stands, and use of "safe and sane fireworks" (as defined in state law) within the City during specified dates and times around the Fourth of July season, with a prohibition on "dangerous fireworks" (as defined in state law) subject to specified exceptions, be adopted? **Supporters:** Carson Christian Center; Carson High Boosters; Filipino Comm. CITY OF COMMERCE – (1)

VOTE PASSAGE – Majority Vote 50%+1

- PC-** Commerce Essential Services Protection Measure: To protect local funding threatened by State gaming regulations and maintain police services, 911 emergency response, youth and senior programs, library services, parks, streets, and infrastructure, shall the City of Commerce enact a ¼-cent (0.25%) transactions and use (sales) tax, providing approximately \$4.5 million annually for general government use until ended by voters, with annual audits and public disclosure? **Supporters:** Brenda Villa; Stephanie Mejia; Rolando Canobbio; Timothy Cam **Opponents:** None submitted.

COMPTON UNIFIED SCHOOL DISTRICT – (1)

VOTE PASSAGE – 55% of the Votes Cast

- CPT-** To fix deteriorating roofs, plumbing, heating, electrical and other systems, enhance school safety, and construct, renovate, rehabilitate and modernize classrooms, sites and facilities, including media and performing arts centers, technology centers and athletic complexes, shall Compton Unified School District's measure authorizing \$360,000,000 in bonds at legal rates be adopted, with average levies of \$60 per \$100,000 assessed value (approximately \$22,000,000 annually) while bonds are outstanding, with citizen oversight, no money for administrative salaries, and all money locally controlled? **Supporters:** Caleb Oliver **Opponents:** Anthonia Limon

CITY OF COVINA – (1)

VOTE PASSAGE – Majority Vote 50%+1

- CC-** **Covina Public Safety, Local Control, and Accountability Measure.** To maintain local funding for 911 emergency medical, fire, and police services; clean up encampments; address homelessness; improve city parks and facilities, repair streets and potholes, and provide senior and youth recreation programs, shall the City of Covina adopt an ordinance implementing a supplemental ¼ cent sales tax, providing approximately \$3,000,000 annually, remaining in effect until ended by voters, with money staying in the City? **Supporters:** John King & Patricia Cortez, Councilmembers; Kevin Stapleton & Lynda Noriega, Finance Commissioners; Covina Police Association **Opponents:** None submitted

CITY OF GARDENA – (1)

VOTE PASSAGE – Majority Vote 50%+1

- GG-** City of Gardena Services Measure. Shall the measure providing long-term funding for City of Gardena's general services, such as maintaining fire, paramedic, police, 911 response; hiring and retaining well-trained police helping prevent property crimes; keeping public areas/parks safe/clean; addressing homelessness; repairing streets and potholes; maintaining afterschool programs and senior services; by establishing a ¼¢ sales tax, providing approximately \$3,900,000 annually until ended by voters, requiring audits, public spending disclosure, all funds controlled locally, be adopted? **Supporters:** Leonard Kim, Owner Cherrystones; Gardena Mgmt Employee Assn; Gardena Munc Employee Assn; J.Bettencourt, Russ International **Opponents:** None submitted.

CITY OF INGLEWOOD – (1)

VOTE PASSAGE – Majority Vote 50%+1

- I-** **Ordinance to Amend the Inglewood Fire Code to Permit the Sale and Use of Certain Fireworks Within the City of Inglewood.** Shall an ordinance be adopted that repeals the City's existing ban on the public's use of Safe and Sane Fireworks, permits their sale within Inglewood under a regulated framework, and establishes rules and penalties for violations? **Supporters:** Inglewood Blackhawks, Junior All American; KDS Associates, Omega Gents; Wanda Wallace **Opponents:** None submitted.

LA CAÑADA UNIFIED SCHOOL DISTRICT – (1)

VOTE PASSAGE – 55% of the Votes Cast

- LCF-** To upgrade aging classrooms/labs supporting student achievement and college/career readiness in math, science, technology, engineering, arts, and skilled trades; fix deteriorating plumbing, roofs, heating, ventilation, and electrical systems; remove hazardous materials/asbestos/lead; and repair, construct/acquire classrooms, labs, facilities/equipment, shall La Cañada Unified School District's measure be adopted authorizing \$113,000,000 in bonds at legal rates, levying \$29/\$100,000 assessed value (\$7,000,000 annually) while bonds are outstanding, with independent oversight/audits and all funds locally-controlled? **Supporters:** Mike Leininger, LC Chamber; Joe Radabaugh, LCUSD Bd; Seun Han, LCE PTA; Donald Voss, Fmr LCF Mayor; Tamar Tujian, Fmr PTA Cnl Pres **Opponents:** None submitted.

CITY OF LA PUENTE– (1)

VOTE PASSAGE – Majority Vote 50%+1

- LP- Keep La Puente Sales Tax Revenues Local Measure.** To protect La Puente's funding for public safety; street/sidewalk maintenance/repair; park maintenance/enhancements; youth/senior programs and any other governmental purposes and prevent the County of Los Angeles and other taxing agencies from seizing additional sales tax revenues generated in La Puente for themselves, shall La Puente's 1/2% transactions (sales) and use tax be increased to 1% raising an additional \$3.6 million annually, subject to the ability to suspend application of the increased rate?

LAWNDALE ELEMENTARY SCHOOL DISTRICT – (1)

VOTE PASSAGE – 55% of the Votes Cast

- LL-** With no projected increase to current tax rates, shall Lawndale Elementary School District's measure to continue modernization of outdated classrooms and school facilities; enhance school security and student safety; and replace aging plumbing and electrical systems; issuing \$42,000,000 of bonds at legal rates be adopted, generating on average \$2.8 million annually while bonds are outstanding at rates of approximately \$30 per \$100,000 assessed value, with citizens' oversight, annual independent audits, and all money staying local? **Supporters:** None submitted

LITTLE LAKE CITY ELEMENTARY SCHOOL DISTRICT – (2)

VOTE PASSAGE – 55% of the Votes Cast

- LR- LITTLE LAKE CITY SCHOOL DISTRICT CLASSROOM REPAIR, HEALTH, SAFETY MEASURE.** To repair aging classrooms, plumbing/electrical/gas lines, leaky roofs; remove asbestos, lead paint, mold; maintain safe drinking water; upgrade emergency communications/safety/security systems; improve disabled student accessibility; acquire, construct, repair facilities, sites, equipment, shall Little Lake City School District's measure authorizing \$45,000,000 in bonds at legal rates, levying 3¢/\$100 assessed value (\$3,100,000 annually) while bonds are outstanding, be adopted, requiring public spending disclosure, audits, oversight, all funds for local schools? **Supporters:** Ralph Aranda, 24 Hour Real Estate; Richard Moore, Fmr. - LS- LITTLE LAKE CITY SCHOOL DISTRICT CLASSROOM EDUCATION/STUDENT ACHIEVEMENT/TEACHER RETENTION MEASURE.** To update classrooms, improve student access to instruction in science, engineering, math, arts, music, early literacy; upgrade 21st century classroom learning technology, helping retain/attract quality teachers; acquire, construct, repair facilities, sites, equipment, shall Little Lake City School District's measure authorizing \$45,000,000 in bonds at legal rates, levying 3¢/\$100 assessed value (\$3,100,000 annually) while bonds are outstanding, be adopted, requiring public spending disclosure, audits, oversight, all funds for local schools? **Supporters:** Ralph Aranda, 24 Hour Real Estate; Richard Moore, Fmr. CITY OF LOMITA – (1)

VOTE PASSAGE – Majority Vote 50%+1

- LW-** **City of Lomita Local Control/Services Measure.** To maintain Lomita’s long-term financial stability and general city services, including sheriff/emergency response; theft/burglary/property crime prevention; keep public parks/public areas safe/clean; repair streets/potholes, old stormwater/sewer pipes; maintain parks and gang prevention efforts; address homelessness, shall a measure be adopted establishing a ¼¢ local sales tax, providing approximately \$650,000 annually until ended by voters, requiring audits/public spending disclosure, all funds, locally controlled? **Supporters:** Cindy Segawa, Mayor; Lomita Firefighter Assn; Robert Luna, Sheriff; C.Chartier, Grocery Outlet Owner; J.Bayouth, Harrys BBQ Owner **Opponents:** None submitted.

CITY OF LOS ANGELES – (3)

VOTE PASSAGE – Majority Vote 50%+1

- CB-** **APPLYING CANNABIS BUSINESS TAXES TO UNLICENSED CANNABIS BUSINESSES. PROPOSITION CB.** Shall an ordinance be adopted to apply the City's existing cannabis business taxes to unlicensed cannabis businesses at current rates (10% on cannabis sales; 5% on medical cannabis sales; 2% on manufacturing, cultivation or other commercialization; 1% on transportation, testing or research); generating approximately \$30-35 million annually for general City services, such as street/sidewalk repairs, 911 emergency response, fire protection, and parks, until ended by voters? **Supporters:** None submitted **Opponents:** None submitted.
- TC-** **APPLYING TRANSIENT OCCUPANCY TAX TO ONLINE TRAVEL COMPANIES. PROPOSITION TC.** Shall an ordinance be adopted to update the City's transient occupancy tax, paid by hotel and lodging guests, to require on line and other travel companies to collect and remit the tax (the current rate is 14%); generating approximately \$5 million annually for general City services, such as street and sidewalk repairs, 911 emergency response, fire protection, and parks, until ended by the voters? **Supporters:** Tim McOsker, Councilmember, District 15, City of Los Angeles **Opponents:** None submitted.
- TT-** **FUNDING FOR CITY SERVICES THROUGH MODIFICATIONS TO THE TRANSIENT OCCUPANCY TAX. PROPOSITION TT.** Shall an ordinance be adopted to fund general City services, such as street/sidewalk repairs, 911 emergency response, fire protection, and parks, by: increasing the transient occupancy tax, currently 14% paid by hotel and lodging guests, to 16% through 2028 and then 15% thereafter; and requiring online and other travel companies to collect and remit the tax; generating approximately \$22-44 million annually until ended by voters? **Supporters:** None submitted **Opponents:** Councilman S. CITY OF MONTEREY PARK – (1)

VOTE PASSAGE – Majority Vote 50%+1

- NDC-** **Proposition to Prohibit Data Centers in Monterey Park.** Shall the ordinance amending the City of Monterey Park General Plan to prohibit data centers citywide to protect air quality, drinking water resources and public health; prevent impacts to electricity and water rates; with the prohibition of data centers continuing until ended by voters, be adopted? **Supporters:** Vinh Ngo, Council Member; Elizabeth Yang, Mayor; Henry Lo, Pro Tem; Jose Sanchez, Council Member; Thomas Wong, Council Member. **Opponents:** None submitted.

CITY OF PALOS VERDES ESTATES – (1)

VOTE PASSAGE – Majority Vote 50%+1

- PF-** Shall the measure to maintain the City of Palos Verdes Estates Police Department and fire protection/emergency medical services provided by the Los Angeles County Fire Protection District; maintain emergency response times/police patrols, home burglary prevention patrols; prepare for wildfires by reducing fire risk; by extending the City of Palos Verdes Estates parcel tax for 10 years at the rate of \$990 plus 67¢ per square foot of building improvements, generating approximately \$16,200,000 annually, with annual adjustments, requiring citizen oversight committee, public spending disclosure/independent financial audits, be adopted? **Supporters:** PVE Police Officers Association; Kate Greenberg, Former PVE Treasurer; Bob Wade; Christian Campisi; Steve Friedrich. **Opponents:** John Williams; Arthur Fine; Phyllis Scribe; Thomas Maier; Thomas Bosseler

PASADENA GLENN COMMUNITY SERVICES DISTRICT – (1)

VOTE PASSAGE – 2/3 Votes (66.6% of Votes)

- B-** Shall the measure to maintain and improve Pasadena Glen roads and culverts, by enacting a District special parcel tax at \$800 per year for each legal-address property within the District, subject to annual Construction Cost Index (“CCI”) adjustments not to exceed 5% annually, generating approximately \$52,000 annually; until ended by voters, with all revenues remaining in the District and subject to annual reporting and Board oversight, be adopted? **Supporters:** Sergio Sotolongo; Mala Arthur **Opponents:** None submitted.

CITY OF POMONA – (1)

VOTE PASSAGE – Majority Vote 50%+1

- Z-** POMONA KIDS FIRST FUNDING AMENDMENT: Shall the measure to amend the City Charter and adopt an ordinance amending the funding for the "Pomona Children and Youth Fund" Initiative (Measure Y) to provide guaranteed, measurable funding at 10% of the City's Bradley-Burns Local Sales and Use Tax rather than a percentage of the City's General Fund, and updating procedures to administer the Fund under the Act, be adopted? **Supporters:** Tim Sandoval; Jeanette Ellis Royston; Steve Lustro; Lorraine Canales; Nora Garcia **Opponents:** None submitted.

CITY OF SAN MARINO – (1)

VOTE PASSAGE – Majority Vote 50%+1

- S-** To maintain funding (that The State of California and Los Angeles County cannot take) exclusively for City of San Marino services including: repairing streets/sidewalks/alleyways/potholes and other City infrastructure, improving public safety, providing youth and senior programs, library and park maintenance and enhancements, and general government use; shall the City of San Marino measure be adopted levying a 1 percent transaction and use tax, raising \$1,651,000 annually, until ended by voters? **Supporters:** Tony Chou; Calvin Lo; Hunter Chang; John Chou; Gretchen Shepherd Romey **Opponents:** None submitted

CITY OF SIERRA MADRE – (1)

VOTE PASSAGE – Majority Vote 50%+1

- GL-** **City of Sierra Madre No-Tax Increase Gann Measure.** Shall the measure adjusting the City of Sierra Madre's appropriations limit to allow increased budgeting of City revenues for general governmental purposes, including protecting safe clean water, maintaining brush clearing and wildfire prevention,, firefighter/paramedic staffing levels, 911 emergency response, repairing potholes, streets, and sidewalk, upgrading storm drains to protect local groundwater supplies, maintaining natural disaster preparedness for four years (this measure does not increase taxes or impose any new taxes), be adopted? **Supporters:** Kris Lowe, Mayor; Sue Spears, City Treasurer; SM Firefighter Assn; Mike Kefalas, Only Place in Town; Sandy Duvall, Sierra Fitness **Opponents:** None submitted.

SOUTH PASADENA UNIFIED SCHOOL DISTRICT – (1)

VOTE PASSAGE – 55% of the Votes Cast

- SP-** To upgrade classrooms, labs, career training and school facilities to support college/career readiness in math, science, engineering, arts, and skilled trades; repair/equip/modernize older facilities to meet current health codes, safety codes, and disabled student access; and update instructional technology/IT infrastructure, shall South Pasadena Unified School District’s measure authorizing \$128,000,000 in bonds at legal rates be adopted, levying \$48/\$100,000 assessed value (\$7,325,000 annually) while bonds are outstanding, with independent oversight/audits/all money locally controlled? **Supporters:** Kim England, SP Teachers Assn; Rob Clyde, SPEF; Grace Kung, SP Chinese-American Club; Dr. Patricia Martinez-Miller, SPUSD Board **Opponents:** None submitted.
