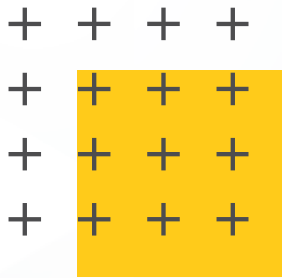

# ABOUT THIS ELECTION



## Election Overview

The June 2, 2026 Statewide Direct Primary Election is being held to vote on voter-nominated offices, local offices, and local measures. All voters can participate in this election regardless of party preference.

**Voter-Nominated Offices:** Governor, Lieutenant Governor, Secretary of State, Controller, Treasurer, Attorney General, Insurance Commissioner, Board of Equalization, United States Representative, State Senator, and State Assembly Member.

**Local Offices:** County Board of Supervisors, Sheriff, Assessor, Superior Court Judge, Local Districts, and City Contests.

**State Nonpartisan Office:** Superintendent of Public Instruction.

## Impact of State Measure 50 and Redistricting

- State Measure 50 was approved by voters during the November 4, 2025 Statewide Special Election. Under this measure, California will use temporary, legislatively drawn Congressional district maps until new maps are drawn following the 2030 U.S. Census.
- State Measure 50 does not affect current State Senate, State Assembly, or State Board of Equalization district lines.
- Voters whose Congressional district boundaries have been redrawn will see contests and candidates for their new district.

# ELECTION TIMELINE

## April 17, 2026

### Sample Ballots and Voter Information Guides Mailing

The California Secretary of State and Los Angeles County Registrar-Recorder/County Clerk sends every registered voter a Voter Information Guide and Sample Ballot Book containing important election and voting information on candidates and measures.

## May 18, 2026

### Voter Registration Deadline

This is the last day for eligible voters to register to vote and be mailed a Vote by Mail ballot. Eligible voters who miss this deadline can still vote at any Vote Center beginning May 23, 2026.

## May 26, 2026

### Last day to request a Vote by Mail ballot

This is the last day voters can request a replacement ballot or request a Crossover Vote by Mail ballot.

## June 2, 2026

### Election Day

This is the last day voters can participate in the General Election. All Vote Centers and Ballot Drop Boxes will be open from 7 AM to 8 PM.

## June 26, 2026

### Certified Election Results

The Registrar-Recorder/County Clerk is scheduled to certify election results.

## April 30, 2026

### Vote by Mail Ballot Mailing & Drop Boxes Open

In California, Vote by Mail ballots must be mailed at least 29 days before Election Day. Given the size of Los Angeles County, ballots in a Countywide election are often mailed before the required deadline. Vote by Mail Drop Boxes open the same day ballots are mailed.

## May 23, 2026

### Initial Vote Centers Open

In-person voting at a Vote Center will begin on Saturday, May 23, 2026. Vote Center locations will be open daily.

## May 30, 2026

### All Vote Centers Open

All Vote Center locations are open through Election Day, June 2, 2026. Hours and locations will be available on LAVOTE.GOV.

## June 3, 2026

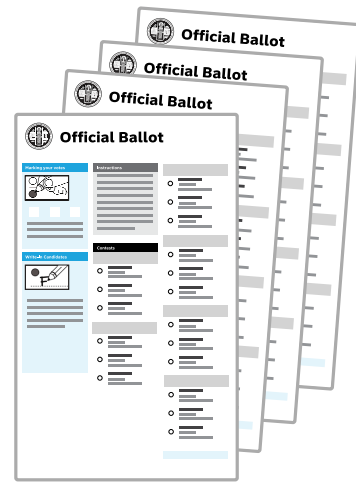
### Official Election Canvass

The Official Election Canvass is a 30-day period where the RR/CC processes and verifies all outstanding ballots to ensure every eligible ballot cast by Election Day is counted.

# PRIMARY ELECTION INFORMATION AND RESOURCES

The Statewide Direct Primary Election features a large and competitive ballot, with numerous candidates running for federal, state, and local offices.

All candidates who qualified for the ballot will appear, even if they have since withdrawn or suspended their campaign. This ensures consistency and accuracy in the official ballot as required by election law.

With a long ballot, making your selections in advance can make all the difference.

# VOTER REGISTRATION GUIDANCE FOR DISPLACED RESIDENTS

If you've been temporarily displaced by the recent wildfires, you can keep your voter registration at your residential (home) address and add a temporary mailing address to ensure you continue receiving election materials.

This ensures you can vote in elections tied to your home address without changing your voting districts. Updating your mailing address does not affect your eligibility to vote in local elections.

## How To Update Your Voter Registration

You have two simple options to update your mailing address:



### Option 1: Online

1. Visit [LAVOTE.GOV](https://LAVOTE.GOV) or [RegisterToVote.ca.gov](https://RegisterToVote.ca.gov) to re-register to vote.
2. Enter your residential (home) address in the "Home Address" section.
3. In the "Mailing Address" section, check the box that says your mailing address is different from your home address.
4. Enter your temporary mailing address.

**Important:** Only update your mailing address. Do not change your home address unless you have permanently relocated. Your home address determines your voting districts.



### Option 2: Phone

- Call **(800) 815-2666, option 2** for help updating your registration with a mailing address.

## If You've Permanently Relocated

If you've permanently moved, you should update your home address. This change will update your voter record and determine your eligibility to vote in local elections and contests tied to your new residential address.

# VOTE BY MAIL AND BALLOT DROP BOX INFORMATION



## Voting by mail

Every registered voter in Los Angeles County is mailed a Vote by Mail ballot at least 29 days before Election Day. Given the size of Los Angeles County, ballots will be mailed early on **April 30, 2026**.

It's encouraged to return your ballot early — at least seven (7) days before Election Day to ensure timely delivery. Ballots must be postmarked on or before Election Day, no postage required.

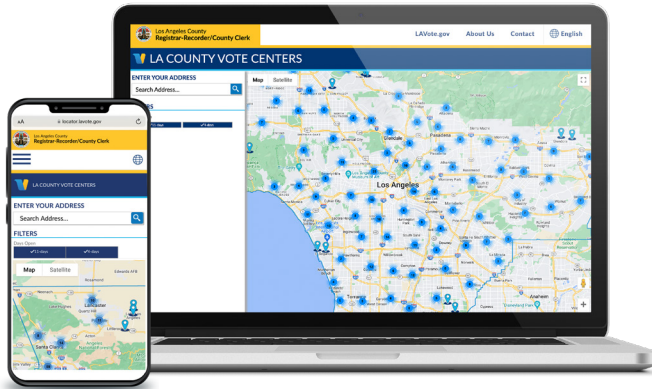


## Safety and Security

- Ballot Drop Boxes provide voters with a safe, accessible, and contact free method to return their voted ballot
- Ballots are picked up regularly by two designated RR/CC staff
- Bolted securely into cement or chained in place at each location
- Designed with security features identified in state regulations
- All boxes have an exterior coating to reduce permanent graffiti or damage
- The County works with law enforcement agencies, cities, local stakeholders, and community-based organizations to monitor and safeguard all boxes

# MEDIA AT THE VOTE CENTER



## Visiting a Vote Center

The voting period and Election Day is an exciting time. **Reporters, journalists, and various media representatives are allowed to visit any Vote Center and capture voting activities.** However, there are guidelines that the media must follow to ensure we maintain a positive and smooth voting experience.



## Media Are Allowed To:

- Enter the Vote Center
- Take photos and videos of the interior of the Vote Center
- Take photos and videos of the exterior of the Ballot Marking Devices (BMDs) while occupied
- Take photos and videos of the interior of a BMD if unoccupied
- Take photos and videos of voters and/or Election Workers
- Conduct interviews with voters -- if a voter agrees, the interview should be conducted outside of the Vote Center



## Media Are Not Allowed To:

- Block the entrance, exit, or pathway to the Vote Center
- Take photos or videos of the interior of the Ballot Marking Devices (BMDs) while occupied by voters
- Take photos or videos of voted ballots before they are deposited inside the BMD (this violates voter's privacy)
- Conduct interviews with Election Workers
- Take photos or videos of voters or Election Workers who express they do not want to be photographed or on camera

## Media at the Ballot Processing Center

Media is welcome to visit the Ballot Processing Center while election-related activities are taking place, beginning May 4 through election certification.

### Ballot Processing Center on Election Day and Night:

- **WHEN:** June 2 from 7:00 AM – Announcement of Election Day Semi-Final Results
- **WHERE:** 13401 Crossroads Parkway North, City of Industry, CA 91746
- **PARKING:** Limited parking will be available on a first-come-first-serve basis
- **CREDENTIALS:** Media members must present their credentials upon entering the BPC
- **COVERAGE AND FILMING:** Media can capture footage of activities in designated areas

# BALLOT PROCESSING CENTER

## About the Facility

The Ballot Processing Center is a state-of-the-art facility and central hub for processing, verifying, and counting all ballots in Los Angeles County.



## Operations Inside

### Vote by Mail (VBM)

- Receiving ballots from the United States Post Service and Ballot Drop Boxes
- Verifying all VBM ballots with the voter's signature
- Processing and preparing ballots to be tallied

### Tally Operations




- Receiving Vote Center and VBM ballots throughout the voting period and on Election Day
- Inspecting and preparing ballots to be tallied on Election Night
- Tabulating and reporting election results

### Official Election Canvass Operation

- 1% Manual Tally
- Processing of Conditional Voter Registration and Provisional Ballots
- Processing Write-in Candidates

## Safety and Security

Transparency remains a cornerstone in our mission of administering elections, similar to ensuring the safety and security of all election workers, election staff, and the ballots that are returned.

## Remaining Results: Ballots cast at a Vote Center on Election Day

### Process and Timing:

- When Vote Centers close, Election Workers will complete their closing procedures and then deliver their ballots to Sheriff's Deputies at a designated Check-in Center.
- Sheriff's Deputies then transport ballots from the Check-in Center to the Ballot Processing Center to be processed and counted.
- All ballots cast at the Vote Center on Election Day will be counted and reported. Once all ballots are counted, we will release the Semi-Final Results.

## Reporting Results after Election Night

It's important to know that counting ballots and reporting results does not end on Election Night. All Vote by Mail ballots cast by Election Day and received within seven (7) days from Election Day will be accepted, processed, and once verified, counted.

All Conditional Voter Registration (same-day registration) and Provisional Ballots cast on Election Day are processed and added to the tally once they are cleared.

## TRANSPORTING BALLOTS FOR TABULATION



On Election Night, ballots from all Vote Centers are brought to the RR/CC Ballot Processing Center (BPC) in the City of Industry for central tabulation.

After the Vote Centers close at 8 PM, Election Workers will secure the voted ballots in sealed ballot boxes and account for unused ballots. Election Workers will also separately package Vote by Mail ballots that were dropped off at Vote Centers. All materials and quantities are accounted for in the Official Ballot Statement. Then Election Workers transport the ballots to designated Check-In Centers located throughout the County.

Sheriff Deputies transport the voted ballots from the Check-in Centers by car, helicopter or boat to the BPC. Ballots come in from as far away as Lancaster, Palmdale and Catalina Island.

Between 10:30 – 11:30 PM a large number of ballots begin to arrive at the BPC.

Prior to tabulation, all ballots must be checked in, removed from boxes, inspected and prepared for counting.

Ballots are moved to the tabulation center in a continuous flow. There, operators load the ballots onto scanners for tabulation.

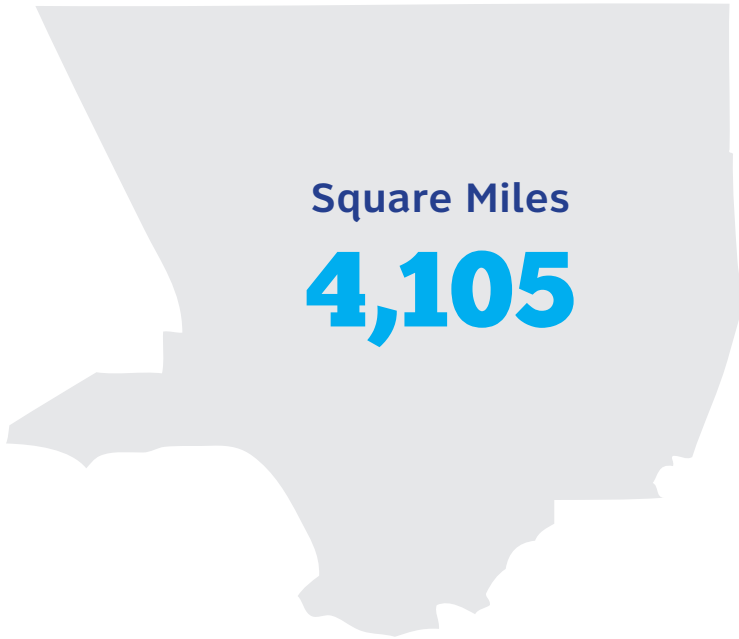

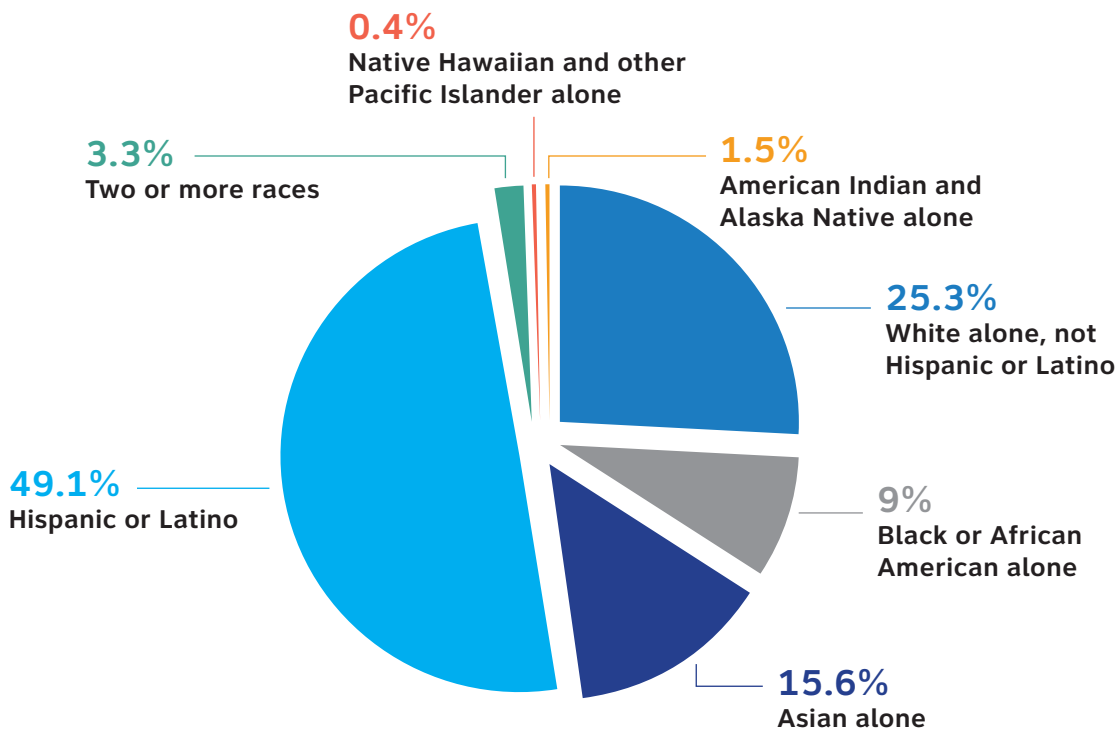

- ▲ The easiest way to register is online at **LAVOTE.GOV**.
- ▲ Registration applications are also available at most government buildings, including public libraries, Department of Motor Vehicles (DMV) offices, Post Offices, and the Registrar-Recorder/County Clerk offices.
- ▲ To receive a Vote by Mail ballot, voters must register by **May 18**.

### ● CAN I VOTE IF I MISS THE REGISTRATION DEADLINE?

- ▲ Yes. Eligible voters can register and vote in person at any L.A. County Vote Center through Conditional Voter Registration (aka same-day voter registration).

### ● WHEN SHOULD I UPDATE MY VOTER REGISTRATION?

- ▲ Update your registration if you:
  - Permanently moved
  - Change your name
  - Want to change your political party
- ▲ Updates can be completed at **LAVOTE.GOV** or at any Vote Center

### ● CAN I UPDATE MY VOTER REGISTRATION INFORMATION AT A VOTE CENTER?

- ▲ Yes. You can update your registration at any Vote Center in L.A. County.

### ● IF I UPDATE MY ADDRESS, WILL I RECEIVE A NEW VOTE BY MAIL BALLOT?

- ▲ Yes. A new Vote by Mail ballot will be sent automatically.
- ▲ If a ballot was already mailed to your previous address, it will be voided and not counted if returned.

### ● CAN I REGISTER AND VOTE IF I DON'T HAVE A PERMANENT ADDRESS?

- ▲ Yes. Voters who are unhoused or are experiencing homelessness can register using:
  - Cross streets of their current location
  - A temporary residence
- ▲ A mailing address (i.e., shelter, P.O. Box) is required to receive election materials.

## VOTER REGISTRATION FOR PEOPLE DISPLACED BY WILDFIRES

### Q DO I NEED TO UPDATE MY REGISTRATION IF I'VE BEEN TEMPORARILY DISPLACED?

- ▲ No. If your move is temporary, keep your residential address the same; your voting districts and eligibility for local contests will stay the same.
- ▲ You may add a temporary mailing address to ensure you continue to receive your ballot and election materials at your current location.

### Q HOW DO I ADD A TEMPORARY MAILING ADDRESS TO MY REGISTRATION?

- ▲ Online: Visit **RegisterToVote.ca.gov** and select the box that says, "My mailing address is different from my home address."
- ▲ Phone: Call our Voter Information Hotline at **(800) 815-2666, option 2** to update your mailing address.

### Q WILL I STILL BE ABLE TO VOTE ON LOCAL ISSUES TIED TO MY HOME COMMUNITY?

- ▲ Yes. Your home address determines your voting district. You can vote on all contests related to your home address, even if you've added a different mailing address.

### Q WHAT HAPPENS IF I PERMANENTLY MOVED?

- ▲ You must re-register at your new address.
- ▲ Your voting districts and ballot will be updated to reflect your local contests tied to your new residential address.

## VOTE BY MAIL (VBM)

### Q WHEN WILL I RECEIVE MY VOTE BY MAIL BALLOT?

- ▲ Ballots are mailed beginning **April 30**.
- ▲ Voters can sign up to receive automatic text, email, or voicemail notifications on the status of the ballot – from delivery to when it's counted – with Where's My Ballot? at **california.ballottrax.net/voter**.

### Q WHAT IF I DON'T RECEIVE A BALLOT OR IT GETS DAMAGED?

- ▲ Voters can request a replacement ballot at **LAVOTE.GOV/REPLACEBALLOT**.
- ▲ The last day to request a replacement is **May 26**.
- ▲ You may email **votebymail@rcc.lacounty.gov** or call **(800) 815-2666, option 2**.

### Q WHY DO I NEED TO SIGN THE RETURN ENVELOPE?

- ▲ Your signature is required to verify and count your ballot.

# JUNE 2026 STATEWIDE DIRECT PRIMARY ELECTION FAQ

## VOTE BY MAIL (VBM) CONTINUED

### Q DO I PUT MY BIRTHDAY ON THE RETURN ENVELOPE OR THE DATE OF RETURN?

▲ Enter the date the ballot is returned. If a voter enters their birth date instead, the ballot will still be processed and, once verified, counted.

### Q HOW CAN I RETURN MY BALLOT?

▲ At any Official Ballot Drop Box. The nearest locations are included in the Vote by Mail packet and available online at **LAVOTE.GOV/DROPBOX**.

▲ By mail (no postage required).

▲ At any Vote Center beginning **May 23**.

#### ▲ Important:

- If returning by mail, send your ballot at least seven (7) days before Election Day to ensure timely delivery.
- Ballots must be postmarked on or before Election Day to be counted.

### Q WHAT DO I DO IF I RECIEVE A BALLOT THAT’S NOT ADDRESSED TO ME?

▲ Write “Moved – no longer here” on the envelope and place it back in the mail.

### Q WHAT IF I FORGOT TO SIGN MY BALLOT, OR MY SIGNATURE DOESN’T MATCH?

▲ If your signature is missing or if the signature doesn’t match, you will be contacted with instructions and a deadline to ensure your ballot is counted.

## VOTING IN-PERSON

### Q WHEN WILL VOTE CENTERS OPEN?

▲ Vote Centers will be open daily beginning Saturday, May 23, from 10 AM to 7 PM, and from 7 AM to 8 PM on Election Day.

### Q HOW CAN I FIND A VOTE CENTER?

▲ Visit **LOCATOR.LAVOTE.GOV** or call **(800) 815-2666, option 1**.

▲ Every registered voter will be mailed a separate mailer in May listing the nearest Vote Center locations to their home.

### Q HOW ARE ELECTION WORKERS PREPARED TO HANDLE CONCERNS AT VOTE CENTERS?

▲ Election Workers are trained to maintain situational awareness, identify potential issues, and follow established escalation protocols to address concerns while ensuring voting continues without disruption.

## VOTING IN-PERSON CONTINUED

### ● HOW DOES THE COUNTY ENSURE VOTING LOCATIONS REMAIN SAFE AND FREE FROM INTIMIDATION?

- ▲ Voting locations are established to ensure every voter can cast a ballot safely and without interference.
- ▲ State law prohibits intimidation and disruption of the voting process, and our operations are designed to support a secure and accessible voting environment.

### ● WHAT SHOULD VOTERS DO IF THEY FEEL UNCOMFORTABLE AT A VOTING LOCATION?

- ▲ Voters always have options. They can vote at any Vote Center in the county, return their ballot at an Official Ballot Drop Box, or vote by mail. These options ensure voters can choose the method that feels most comfortable and convenient for them.

### ● ARE THE BALLOT MARKING DEVICES CONNECTED TO THE INTERNET OR A NETWORK?

- ▲ No. The Ballot Marking Devices (BMD) are not connected to the Internet or any network.

### ● DOES THE BALLOT MARKING DEVICE COUNT VOTES?

- ▲ No. The BMD does not count votes. All paper ballots cast in a BMD are securely transported to the Ballot Processing Center every night and counted on Election Night.

### ● DO I NEED TO PROVIDE IDENTIFICATION TO VOTE AT A VOTE CENTER?

- ▲ California law does not require registered voters to show identification when voting.
- ▲ If a voter is registering for the first time, they must provide a valid government photo ID or the last four digits of their Social Security number.

### ● CAN I LEAVE WORK TO VOTE?

- ▲ Yes. California law allows time off if you do not have enough time outside work hours.
- ▲ Employers may provide up to two (2) paid hours.
- ▲ Employers may require advance notice. The time off must be at the beginning or the end of your shift. Employers are required to post a notice about the notice 10 days before a statewide election.

### ● WHAT IF I NEED HELP IN A LANGUAGE OTHER THAN ENGLISH?

- ▲ Vote Centers are staffed with diverse Election Workers who speak the languages commonly spoken in your community. If you need support in a language not spoken at the location, the Election Worker will call the Multilingual Hotline for translation services.

# BALLOT MARKING DEVICE AND ELECTRONIC POLLBOOK

## Ballot Marking Device

The benefits of technology for an easy and accessible voting experience - with a paper ballot.

The Ballot Marking Device makes it easy for voters to customize the voting experience to fit their needs. Voters can access 19 languages, adjust the touch screen to a comfortable angle, change the display settings such as text size and contrast or go through the ballot using the audio headset and control pad.

Security remains a top priority for Los Angeles County, that's why this device is not connected to a network or the internet. The easy-to-follow instructions can guide any voter through the voting process without the need for assistance.

Previously, voters with mobility or visual challenges were asked to go to a separate voting booth; not any more. The Ballot Marking Device provides all the accessibility features previously available and upgrades them all into one device.



## Electronic Pollbook

The Electronic Pollbook (ePollbook) has replaced the paper precinct list of voters and provides Los Angeles County and voters with a modern and secure check-in experience.

Election Workers now have the ability to update voter registration information in real-time allowing voters to visit any participating Vote Center in the Los Angeles County. Voters can securely update their registration information, leave their Vote by Mail ballot at home and still cast a standard in-person ballot, and eligible voters who missed the registration deadline can visit any Vote Center and cast a ballot through Conditional Voter Registration.

The ePollbooks are not connected the Ballot Marking Device or the Tally System to protect voter information and anonymity.



# CANVASS: FINALIZING THE VOTE

## Finalizing the Official Vote Tally (Canvass)

Counting ballots does not end on Election Night. The Registrar's office makes sure all ballots cast are counted. After Election Night there are tens of thousands of ballots that need to be counted, including Vote by Mail ballots received on Election Day, provisional ballots, write-in ballots, and damaged ballots. These ballots are counted during the 30-day period known as the Official Election Canvass. Provisional ballots require additional review to verify voters are eligible to vote and write-in ballots were cast for qualified candidates.

California state law requires the RR/CC to complete and certify the results within 30 days. This provision of the law recognizes the complexity of completing the ballot count and conducting a thorough audit of the election results to ensure accuracy.

The legally mandated processes described above are utilized to guarantee that every eligible vote is counted and included in the official final election returns.

---

## Auditing the Election Results

By law, a random sample of ballots from every election must be manually tallied to verify Election Night machine counts. A minimum of all votes cast in one percent (1%) of the precincts is included in this process, which is known as the 1% Manual Tally Audit. The 1% Manual Tally Audit is open to the public. (E.C. 15360)

---

## Public Observation

Every citizen has the right to observe the Official Election Canvass process. Candidates and the public are invited to observe the ballot counting and auditing process by joining the Election Observer Program. The program is part of Los Angeles County's commitment to conducting open and transparent elections.

Election observers have the opportunity to observe the logic and accuracy testing of the election systems equipment, Vote by Mail ballot processing, Election Day activities at Vote Centers and Check-in Centers, tally center operations and post-election processing.

# REQUESTING A RECOUNT

## Who can request a recount?

Any voter of the state may file a request (E.C. § 15620). For more information download our booklet at [LAVOTE.GOV](https://www.lavote.gov).

## Timing of Request

The request must be filed within five (5) calendar days, after the completion of the official canvass. The RR/CC is not open on weekends or holidays. If the deadline falls on the weekend or holiday, the date will be moved to the next business day (E.C. § 15).

---

## Exceptions

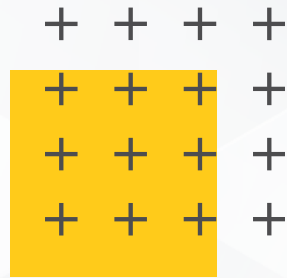
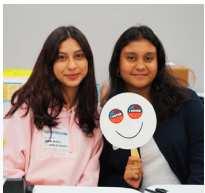
- For statewide recount contests, the request may be filed with the Secretary of State's Office within five (5) days beginning on the 31st day after the election (E.C. § 15621).
  - If election is conducted in more than one county the request may be filed within five (5) days beginning on the 31st day after the election (E.C. § 15620).
- 

## Notice of Recount

A notice stating the date and place of the recount will be posted by the elections official at least one day prior to the recount and the following persons will be notified in person or by telegram (E.C. § 15628).

Notices are issued to the following parties:

- All candidates for the office being recounted.
- Authorized representatives for presidential candidates, if the race for presidential delegates is to be recounted.
- Proponents of any initiative or referendum or persons filing ballot arguments for or against any initiative, referendum or measure to be recounted.
- Secretary of State if the recount is for candidates for any state or federal office, delegates to a national convention, or any state measure.
