**Initial Random Selection:** Batch numbered tickets 1-365 representing 365 Ballot Marking Device (BMD) ballots and batch numbered tickets 1-3,990 representing 3,990 Declared Vote By Mail (VBM) batches for the **June 2, 2026 Statewide Direct Primary Election** were placed inside a rotating drum, and batches were randomly drawn by Elections Official representatives and observers. The initial random selection consisted of four (4) BMD and forty (40) VBM batch numbers.

**Ballot Type:** Optical Scan

**Contest Type:** Single winner (Vote for one candidate or Yes or No for measure); and multi-winners (Vote for more than one)

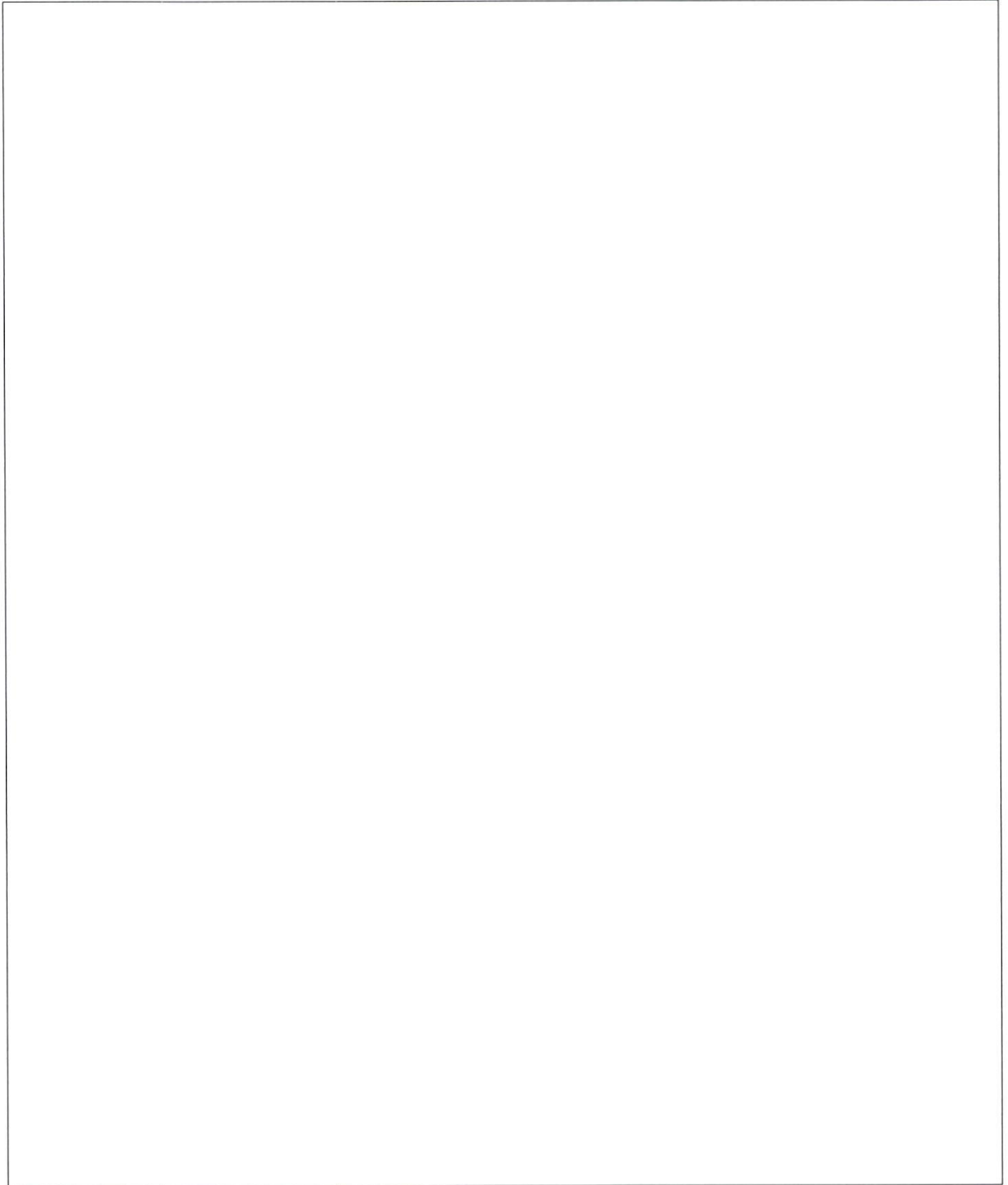

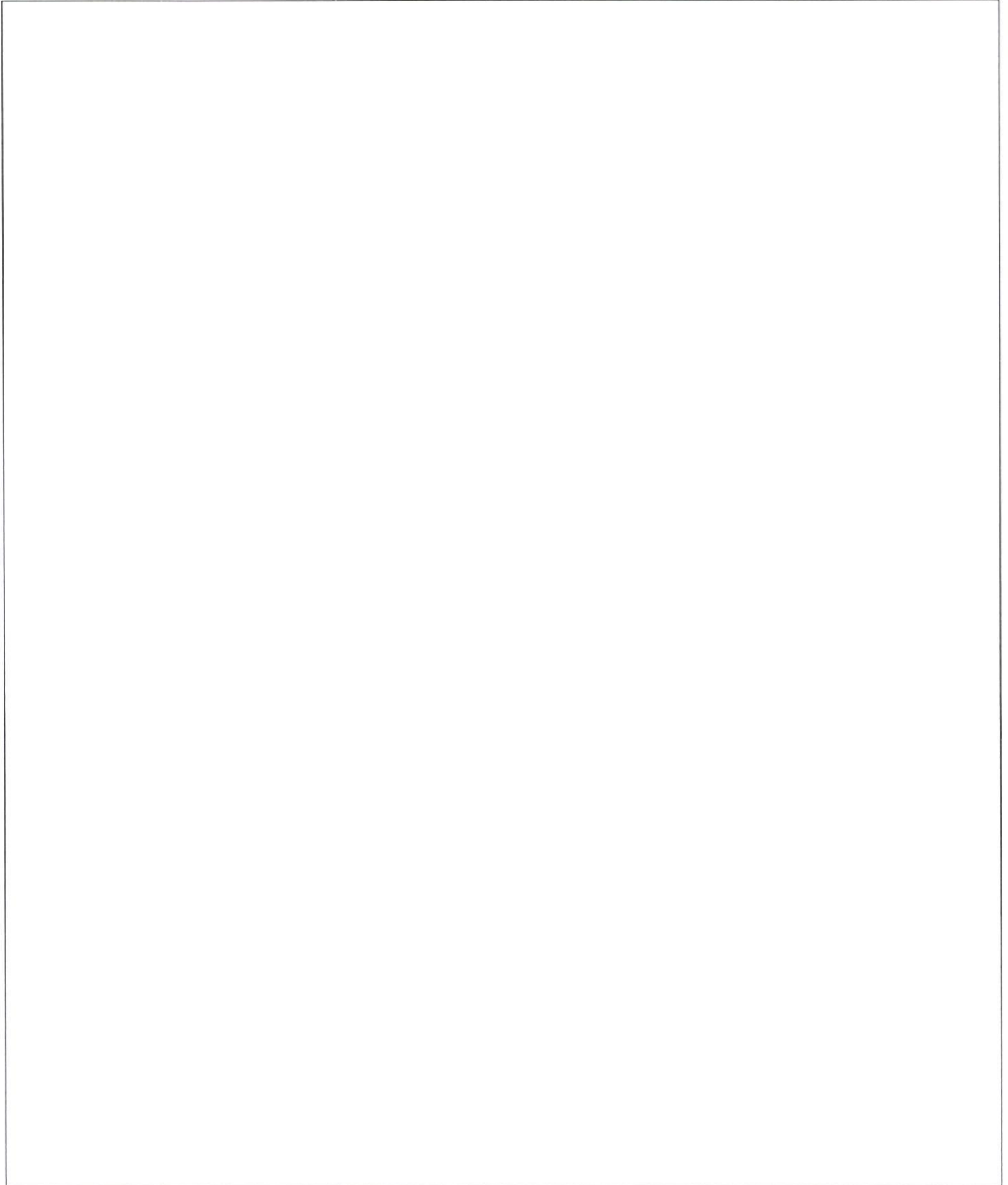
